3. Any faulty product or queries must be advised within 7 days of delivery. No claims valid after 7 days.
4. Retail Prices are suggested only. VAT will apply to all products.
5. Goods returned freight forward will not be accepted unless prior arrangements made.
6. VMD (UK) Ltd reserves the right to change prices as a result of currency fluctuation, devaluation or similar outside influences.
7. VAT is added to all invoices as a separate item.
8. VMD (UK) Ltd reserves the right to extend credit or not and to determine the length and amount.
9. No goods are supplied on consignment or as sale or return.
10. Interest at 3% per month compounding will be charged on overdue accounts.
11. Carriage will be charged at cost.
12. Unless the stockist purchases the display fixtures, then they remain the property of VMD (UK) Ltd and are supplied on loan. The stockist is responsible for any loss or damage to the display. In the event of loss or damage the cost incurred is £150 for a counter stand and £250 for a floor stand. Under no circumstances shall other manufacturer's products be displayed in or on the displays.

General

In no event shall the liability of VMD (UK) Ltd exceed the price of the goods supplied by VMD (UK) Ltd. No servant, agent or contractor of VMD (UK) Ltd has any authority to alter any of its Terms and Conditions of Sale or its Guarantee Policy.

Guarantee Policy

VMD (UK) Ltd guarantees all their products supplied against faulty workmanship or manufacturers defect. Faulty products must be returned within 7 days, to our premises, freight paid, with an explanation of the reason for return. Products will be repaired, replaced or credited in that order. Credits will be processed during the month and details will appear on your statement.
